Finally, an analysis of pending Vehicle Code changes, both in the Legislature and in the Courts, will be discussed.

Specific topics to be covered include, among many others, DUI; DWR; DWS; along with discussions of "hot topic" areas that have been dealt with by the Illinois legislature and the courts which impact upon how the Vehicle Code is construed and enforced.
