# Police Cyclist Registration Ends: May 2, 2018

This is a Nationally Certified Course through the International Police Mountain Bike Association (IPMBA).

A training school for officers and first-time line supervisors in the practical **OBJECTIVES:** application of a Police Bicycle Patrol. The school focuses on the use of the bicycle as a patrol vehicle.

Participants will:

1) Spend approximately half of each eight-hour day riding their bikes and negotiating obstacles; 2) learn to safely handle their bikes while in traffic and while negotiating hazards;

3) learn to use the bicycle to make traffic stops, citizen and suspect contacts, and to safely handle the bicycle in pursuit situations. The Thursday session will involve firearms training.
