TOPICS:

A Brief History of the CAC movement and The Work of the MDT and Why it Matters

This session focuses on the roles and responsibilities of each MDT member and how they work together to achieve best outcomes for children and the investigation. Will discuss challenges of working as a team and how to overcome these challenges.

Forensic Interview Overview

Gives MDT members an overview and understanding of the Forensic Interview Protocol, proper questioning of children, developmentally age-appropriate questioning, and how team members can best support the forensic interview process.

Corroboration in a Forensic Interview

The importance of child's statement not standing alone and what each discipline's role is of gathering corroborative information from the interview, where to look beyond the interview, and understanding problematic behaviors of the child that can be used to help build corroboration.

Case Review

Making case review work for your team, in a practical sense as well as by NCA standards. Discuss the goals and objectives of case review and the why this component is essential for accountability of the cases seen and for improvement of future cases.

He has been a Lead Investigator for child sexual abuse and serious physical abuse since March 1999. He received specialized training in the forensic interviewing of children in 2000. He has conducted over 1100 interviews and has trained hundreds of child protection investigators, prosecutors, and police. He also serves on the faculty of ChildFirst.

Kim Mangiaracino, Children's Advocacy Centers of Illinois, Executive Director. Kim has also served as the statewide MDT Coordinator and Training Coordinator. She also served as a forensic interviewer at the Madison Co. CAC for 7 years, completing more than 2500 interviews. She has a degree from SIUE and serves on the faculty of ChildFirst.
