COURSE CONTENT:

This training has been developed for members of a Tactical Response Team. This training uses various scenario based situations, to cause team members to make immediate deadly force decisions, while under pressure. Officers will work as a group as they practice the various skills necessary to make lawful decisions, avoid injury to officers and survive deadly encounters.

Block 1: (Shoot house)

- Target recognition, shoot/ don't shoot
 - Utilizing various targets that compel the officer to decide whether the target is a threat or no threat.
- Room clearing, groups of 2 or 3
 - Officers will clear rooms with shoot or don't shoot targets present.

Block 2: (MacTac)

- Vehicle bailouts:
 - officers will react to fire while seated in a vehicle. Officers will have to tactically move from the vehicles to positions of cover using bounding and overwatch principles
- L-Shaped ambushes:
 - officers will react to gunfire while on foot patrol as a small unit, they will be graded on using cover to achieve a tactical advantage on the source of gunfire

Uniforms and Equipment: OD green BDU, plate carrier, helmet, weapons systems, and ammunition, shoot/don't shoot targets, target stands and vehicles.

- 1) Live-fire shoot house: 2700 square feet, multiple rooms with ballistic walls and ballistic bullet traps with overhead catwalk for instructor evaluation
- 2) 50-yard general purpose range
- 3) Covered, air conditioned/heated 45-yard general purpose range
- 4) Pistol caliber only steel: Five falling plate racks, dueling tree and Texas Star targets
- 5) 50-yard general purpose range with variable speed moving target system
- 6) Jungle walk: Live-fire tactical and hunting rifle courses with reactive steel targets
- 7) 100-yard general purpose range
- 8) 600-yard rifle range: Variable speed target system
- 9) Two story simulation house: Realty based non-lethal Simunitions type training.
 - Lower floor: 2900 sq. ft., Upper floor: 826 sq. ft.

Mandated Annually

- Law Updates **Use of Force (must include scenario based or similar approved)**

Mandated once every 3 years (begin 1/1/16)

- Civil Rights Constitutional and proper use of law enforcement authority
 Cultural competency Procedural Justice Human Rights

Mandated once every 3 years (begin 1/1/17 all / within 2 yrs. for investigators)

- Trauma Informed Response & Investigation of Sexual Assault & Abuse

Mandated once every 3 years (begin 1/1/18)

- Mental Health Awareness

Mandated 32 hours every 4 years after initial training

- Lead Homicide Investigator training

Mandated once every 5 years /begin 7/1/18 (first (5) year cycle due by 1/1/2020)

- Domestic Violence Act.
