Investigators must have this training and the Investigator specific training completed by 12/31/18.

All Patrol Officers must have completed this training by 12/31/19.

The investigator course is scheduled (3) times in 2018- ~~9/18/18, 10/04/18~~, 11/14/18

This course is in compliance with the Sexual Assault Incident Procedure Act, [Public Act 099-0801](#). The Act is a multi-disciplinary approach to developing best practices in law enforcement, prosecution, hospitals and crime labs for handling sexual assault investigations and prosecutions.

### COURSE CONTENT:

This course will provide initial responding officers with the necessary training to properly investigate sexual assault and sexual abuse incidents with the components for victim centered investigations.

Emphasis will be focused on proper response, law, trauma, evidence collection and report writing, to include victim referrals for trauma-related services. Case based scenarios will be used to provide the framework for the application of this procedure.

***Mandated Annually***

- Law Updates**    Use of Force (must include scenario based or similar approved)

**Mandated once every 3 years** (begin 1/1/16)

- Civil Rights**                       **Constitutional and proper use of law enforcement authority**  
 Cultural competency               **Procedural Justice**               **Human Rights**

**Mandated once every 3 years** (begin 1/1/17 within 2 yrs. for investigators/ all w/in 3 yrs.)

- Sexual Assault Trauma Informed Response**  
 Sexual Assault Trauma Informed Investigator

**Mandated once every 3 years** (begin 1/1/18)

- Mental Health Awareness

**Mandated 32 hours every 4 years after initial training**

- Lead Homicide Investigator training

**Mandated once every 5 years /begin 7/1/18** (first (5) year cycle due by 1/1/2020)

- Domestic Violence Act.
