When perpetrators choke (strangle) their victims, especially to the point of unconsciousness, it is not only a felony, but it may be an attempted homicide. Strangulation is an ultimate form of power and control that can have a devastating psychological effect on victims. The inability to breathe is one of the most terrifying events a person can endure.
